



The MVSB (Meredith Village Savings Bank) “Home Lending Survey Nonprofit Donation” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The MVSB (“MVSB”) “Home Lending Survey Nonprofit Donation” sweepstakes is sponsored by MVSB (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The MVSB “Home Lending Survey Nonprofit Donation” sweepstakes begins at approximately 8:00 am Eastern Time (“ET”) on Thursday, January 2nd and ends at approximately 11:59:59pm ET on Friday, January 31, 2025 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

PRIZE: Winning nonprofits will receive one (1) of five (5) \$500.00 cash donations.

AGREEMENT TO OFFICIAL RULES: By participating in the MVSB “Home Lending Survey Nonprofit Donation” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The sweepstakes is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Prizes may be subject to tax; all applicable taxes are the responsibility of the winner.

ELIGIBILITY: The MVSB “Home Lending Survey Nonprofit Donation” sweepstakes is open to individuals who (a) are legal residents of New Hampshire (b) are at least eighteen (18) years of age at the time of entry. Employees of New Hampshire Mutual Bancorp and its subsidiaries, MVSB, Merrimack County Savings Bank, Savings Bank of Walpole and NHTrust are not eligible to participate in this contest. The decision of Sponsor as to the winning nonprofits is final and binding in all respects. Sponsor has the right to verify the eligibility of each nonprofit before any prize is issued.

ENTRY: Eligible entrants will be emailed a link to complete a survey and cast a vote within the Sweepstakes. Limited to (1) vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.

DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor’s sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies. Any false information provided within the context of the Sweepstakes by any Entrant or noncompliance with these Rules or the like may result in the immediate disqualification of the Entrant from the Sweepstakes. Sponsor reserves the right to disqualify nonprofits that promote lotteries, religious or political messages.

DRAWING AND DISTRIBUTION OF PRIZES: Sponsor will select the winning nonprofits based upon the highest number of votes submitted by voters. Mechanically reproduced or potentially fraudulent votes, as determined by Sponsor in its sole discretion, will be discarded. In the event of a tie, Sponsor will select the winning entry based upon their evaluation of the nonprofit and population served. Sponsor reserves the right not to select any winning submissions based upon the quantity or content of submissions. The decision of Sponsor as to the winning nonprofit is final and binding in all respects.

WINNER NOTIFICATION: MVSB will contact the winning nonprofits on or before February 17, 2025 and will publicize the winning nonprofits on the Bank’s website by on or before March 5, 2025.

ODDS OF WINNING: The odds of winning are dependent upon the total number of eligible entries received.

ADDITIONAL LIMITATIONS: All prizes are non-transferable. No substitution or cash equivalent of prizes is permitted.
