



The Meredith Village Savings Bank “Vote for your favorite nonprofit serving Rochester” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Meredith Village Savings Bank (“MVSBS”) “Vote for your favorite nonprofit serving Rochester” sweepstakes is sponsored by Meredith Village Savings Bank (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The Meredith Village Savings Bank “Vote for your favorite nonprofit serving Rochester” sweepstakes begins at approximately 8:00 am Eastern Time (“ET”) on Thursday, June 2, 2022 and ends at approximately 11:59:59pm ET on Friday, July 15, 2022 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

PRIZE: Winning Nonprofit: ONE (1) \$1000.00 cash donation.

AGREEMENT TO OFFICIAL RULES: By participating in the Meredith Village Savings Bank “Vote for your favorite nonprofit serving Rochester” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The sweepstakes is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Limited to one (1) vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.

DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor’s sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies. Any false information provided within the context of the Sweepstakes by any Entrant or noncompliance with these Rules or the like may result in the immediate disqualification of the Entrant from the Sweepstakes. Sponsor reserves the right not to select any winning submissions based upon the quantity or content of submissions. WINNER NOTIFICATION: MVSBS will contact the winning non-profit on or before July 22, 2022 and will publicize the winning non-profit on the Bank’s social media pages by on or before July 22, 2022.
