

The Meredith Village Savings Bank "Vote for your favorite nonprofit serving Rochester" Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Meredith Village Savings Bank ("MVSB") "Vote for your favorite nonprofit serving Rochester" sweepstakes is sponsored by Meredith Village Savings Bank (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The Meredith Village Savings Bank "Vote for your favorite nonprofit serving Rochester" sweepstakes begins at approximately 8:00 am Eastern Time ("ET") on Thursday, June 2, 2022 and ends at approximately 11:59:59pm ET on Friday, July 15, 2022 (the "Sweepstakes or Voting Period"). Votes/entries received after that date will be deemed ineligible to win.

Limited to one (1) vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.

DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor's sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies.
