



The Meredith Village Savings Bank “Giving Tuesday 2022” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Meredith Village Savings Bank (“MVSBS”) “Giving Tuesday 2022” sweepstakes is sponsored by Meredith Village Savings Bank (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The Meredith Village Savings Bank “Giving Tuesday 2022” sweepstakes begins at approximately 10:00 am Eastern Time (“ET”) on Tuesday, November 22, 2022 and ends at approximately 2:00 pm on Tuesday, November 29, 2022 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

PRIZE: One (1) donation, \$1,000 donation made to a local 501c3 nonprofit from a chosen comment on that Facebook or Instagram post

AGREEMENT TO OFFICIAL RULES: By participating in the Meredith Village Savings Bank “Giving Tuesday 2022” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The sweepstakes is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Prizes may be subject to tax; all applicable taxes are the responsibility of the winner.

ELIGIBILITY: The Meredith Village Savings Bank “Giving Tuesday 2022” sweepstakes is open to individuals who (a) are legal residents of New Hampshire (b) are at least eighteen (18) years of age at the time of entry. DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor’s sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies.
