



The Meredith Village Savings Bank “Small Business Week 2023” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The Meredith Village Savings Bank “Small Business Week 2023” sweepstakes begins at approximately 10:00 am Eastern Time (“ET”) on Monday, May 1, 2023 and ends at approximately 9 pm on Saturday, May 6, 2023 (the “Sweepstakes”). Entries received after that date will be deemed ineligible to win.

PRIZE: One of twelve (12) gift cards to local businesses valued at \$100 each.
