



The MVS B (Meredith Village Savings Bank) “Vote for your favorite nonprofit serving North Conway” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The MVS B (“MVS B”) “Vote for your favorite nonprofit serving North Conway” sweepstakes is sponsored by MVS B (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The MVS B “Vote for your favorite nonprofit serving North Conway” sweepstakes begins at approximately 8:00 am Eastern Time (“ET”) on Monday, November 18, 2024 and ends at approximately 11:59:59pm ET on Friday, January 3, 2025 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

PRIZE: Winning Nonprofit: ONE (1) \$1000.00 cash donation.

AGREEMENT TO OFFICIAL RULES: By participating in the MVS B “Vote for your favorite nonprofit serving North Conway” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. Limited to one (1) in person and one (1) online vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.

DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor’s sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies.
