

The MVSB (Meredith Village Savings Bank) "Lights, Camera, Save! Local Contest" Sweepstakes Official Rules

SWEEPSTAKES PERIOD: The MVSB "Lights, Camera, Save! Local Contest" begins at 12:00:00 a.m. Eastern Time ("ET") on Wednesday, October 1 and ends at 11:59:59 p.m. ET on Sunday, November 30 (the "Sweepstakes or Voting Period"). Votes/entries received after that date will be deemed ineligible to win.

PRIZES:

First Prize: \$500 cash. The first prize winner will also be moved on to the national American Bankers Association (ABA) Lights, Camera, Save! Contest where additional prizes may be awarded.

Second Prize: \$250 cash. Third Prize: \$100 cash.

Children of employees and their immediate family and household members (whether or not related) of the American Bankers Association Foundation, the American Bankers Association, any other participating financial institution, and any of their parent companies, affiliates, subsidiaries, independent contractors, officers, directors, advertising and promotion agencies, and all other entities or individuals associated with the development, administration, or fulfillment of this Contest (collectively, the "Contest Entities") are not eligible to participate in this Contest. All applicable federal, state, and local laws and regulations apply. The decision of the Sponsor is final and binding in all respects. Sponsor has the right to verify the eligibility of each entrant before any prize is issued.

SUBMISSION FORMAT: Videos must be the Entrants original work, in English, and no more than 30 seconds long. They should focus on a money-related topic – like budgeting, credit scores, saving for college, or identity protection – and must not use any copyrighted music, footage, or other media. Entrants may upload their video in common formats such as MP4, MOV, AVI, or WebM, and submit it via YouTube (or a similar video-sharing platform), along with the contestant submission packet to mvsbmarketing@mvsb.com.

ENTRY: Entrants must submit their video entries by emailing a public link to the video posted on YouTube (preferred) or any other video sharing website to mvsbmarketing@mvsb.com along with a completed official entry packet (see Submission Format). Only entries received by November 30 will be considered. Limited to one (1) submission per person. Mechanically reproduced or potentially fraudulent submissions, as determined by Sponsor in its sole discretion, will be discarded.

By entering, Entrants agree to allow MVSB to share their video entries (in whole or in part) on MVSB's website, social media channels, and in other promotional materials as determined by the Bank. MVSB reserves the right to disqualify any entry that does not comply with these rules or the <u>ABA's official rules</u>. MVSB's decisions regarding eligibility, judging, and prize awards are final.

DISQUALIFICATION: Entrant may be prohibited from participating if Sponsor, in Sponsor's sole discretion, reasonably believes that the Entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest Entrants or associated individuals or agencies. Winners will be selected based on the following criteria: creativity and originality; message clarity and impact; relevance to the contest theme of promoting financial responsibility; overall production quality. WINNER NOTIFICATION AND REQUIREMENTS: MVSB will contact the winning Entrants and/or their parent(s)/guardian(s) on or before January 5, 2026. Winning Entrant (if not a minor) or parent or legal guardian of Entrant (if a minor) must submit a physical file of the Video to Sponsor by January 5, 2026, as described in the official entry packet.
